Emergency Manager

Maine's Local Emergency Management Directors coordinate local response and recovery when more than one department is responding to a community emergency. This is usually accomplished in two ways: through the development of local disaster plans and mutual aid agreements and the establishment of an Emergency Operations Center. The local director does not replace or direct the police, fire, ambulance, or American Red Cross; he or she helps them work together in an emergency.

The Local Emergency Management Director also acts as a liaison to County Emergency Management. They can look to the County for technical assistance and training, and emergency access to needed resources, from neighboring communities, the State or the federal government.

Local Emergency Management offices vary widely depending on the hazards present, the size of the town and available funding. Most municipal Emergency Management prorgrams have one person and little to no budget. However, the responsibility for the community does not go away just because the town is small.

When your community is struck by a hazardous materials spill, hurricane, ice storm, forest fire, flood, tornado or other type of disaster event, your municipal Emergency Management Director will step into action to manage the disaster.

Budget Committee

The Town of Mount Vernon budget committee is currently comprised of four individuals. This committee serves in an advisory capacity to the selectmen. Our task is to explore thoughts and ideas that may improve the efficiency and effectiveness of town operations.

We meet most often during the months of late February through May - generally biweekly. We communicate as information is discovered between meetings during that time. The hope of this committee is to be more informed during the rest of the year through quarterly budget updates provided by town employees and officials. New members are always welcome and I would be happy to provide information and answer any questions. Please understand, the town budget is not just about numbers. This committee uses history, experience and common sense (in addition to spreadsheets:)) to make recommendations that help Mount Vernon avoid complacency and keep us moving in a forward and positive direction.

FREE INCOME TAX SERVICES

The AARP Tax-Aide program provides free Federal and State tax return services. Tax-Aide volunteers are trained, tested and certified by the IRS to prepare returns for low and moderate income taxpayers, with particular focus on those over 60, but all are welcome!

Low income taxpayers should note that the only way they can receive the Maine Property Tax Fairness Credit and the Sales Tax Fairness Credit is to file a Maine Income Tax return. Even if you pay no income tax you may be eligible for these credits. These may be worth several hundreds of dollars, depending on your circumstances.

Covid-19 measures will be in effect at all sites. Taxpayers may be asked health-related questions. Masks will be required. Social distancing will be maintained as much as possible.

The free tax services are provided by appointment only by calling January 4^{th} or later and are available at the following sites:

The Dr. Shaw Memorial Library in Mount Vernon (call 293-2565 when the library is open on Saturdays, Mondays and Wednesdays). Tax dates are Tuesdays, March 1, March 15 and March 29, with April 12 as an additional day if needed. This site is intended primarily for Mount Vernon and Vienna residents.

The Cohen Community Center in Hallowell (call 377-8840 Monday through Friday, 11:00 am – 6:00 pm). Tax dates are Wednesdays and Thursdays, February 2 through April 14.

SB Meeting was Called to Order by SB Crockett at 7:01pm

Meeting Minutes of 11-08-21

Motion by SB Libby to accept the meeting minutes as written, 2nd by SB Grenier. Motion Carried. Vote was 3-0. **PASS**

Policy Updates

No Smoking Policy –Motion by SB Grenier to accept the No Smoking Policy as amended, 2nd by SB Crockett. Motion Carried, Vote was 3-0. **PASS**

This qualifies the Town for a \$350 grant. Alice Counts to Forward the signed copy of this policy to the Healthy Communities of the Capital Area.

The remainder of the Policy Manual was tabled until the select board could further review. SB Crockett is looking for an updated version with regards to bidding that was passed in the January 2021 time frame. Treasurer Casey is going to revise the following sections:

Chapter 7 Employee Wages and Benefits Disbursement Warrants – insert verbiage regarding when and how much of the stipend can be requested at once.

Chapter 8 Financial Policies Ordinance – this needs a total rework

Section 8.7.2 Tax Collector/Town Clerk – this is not currently how this job is performed Section 10.3 Filing – Update or reword

Section 11.5.1 Work Week – massage this so that it applies to both the Town Hall and Transfer station.

Section 11.9 Sick Leave and 11.10 Personal Time – Replace with the new law regarding PTO Section 11.11 Delete

SB Grenier stated that the Select Board needs to start considering benefits for employees to stay current with the other towns in this area.

Budget Planning for 2022 -

Treasurer Casey would like a spreadsheet for all payroll. She emphasized the fact that operating costs need to be considered and included in their budge estimates.

Emergency Manager

We are still looking for someone to fill this spot.

Mount Vernon Select Board Meeting Minutes of 11-22-21 (Cont.)

Blake Hill Rd Bridge project

- SB Crockett re-emphasized that the state will close this bridge to all traffic, including foot traffic if we don't reach an agreement.
- If the Town wants the state to contribute 60% of the rebuild costs, then we need to build to the state's standard. This standard would require concrete columns to be constructed on solid ground with the footprint of the bridge expanded in both width and length. The new bridge would also have to be engineered. Barry Skilling, a concerned resident, recommended that we go this route because then if anything were to go wrong, the state would have ownership in this and would have to assume the majority of the liability.
- Barry Skilling mentioned that we should check with the University at Orono to see if we could get a competitive bid for the engineering on this project and also look into a grant to possibly cover the Town's portion of this rebuild.

Annual Audit

Treasurer Casey stated the audit is currently in progress.

E911 Updates

SB Grenier will speak with Andy Dube regarding printing several 2x2 laminated maps which will be available for purchase to the community. These will also be available for Rescue, Fire, Planning Board, CEO and Town Office.

Trio -

SB Crockett stated there is a web version and a hosted version. The Town paid for the web version but did not implement it. He still has some questions that he needs to bounce off Harris Computers before making a final decision. He said he would try and arrange a Zoom Meeting between the Select Board, Clerks, Treasurer and Harris Computers to get these questions answered and better understand some of the problems that currently exist with the software.

Other Business

Map/Lot Index Updates

There is a new index to accompany the Town Map. There is a sort by name, by map/lot and by address.

These indices will be updated monthly so that the information contained within them will always be current.

Alice Counts agreed to provide SB Crockett with an excel file so he can prepare it for Andy Dube at Diversified Drafting for inclusion on the Town Hall Map.

EPA/DEP

SB Grenier has been in contact with DEP as well as some of the residents regarding resolution to the reported dumping in the wetlands. SB Crockett asked SB Grenier to again talk with CEO Butler regarding this issue.

Solar Farms

Ordinance Committee to Review the possibility in support of this for incoming tax revenue. This is go in front of the Town for approval. Decommissioning needs to be looked at to ensure that the owners of any future Solar Farms will take the responsibility of Removing their equipment from the land after it is no longer a viable source of energy.

Planning Board Training

The Select Board approved Alice Counts' request to attend the Planning Board training.

Computer Purchase for Administrative Assistant

The Select Board approved Alice Counts' request to purchase a new computer due to the many issues she has been experiencing with her current system.

Sign at Mooar Hill Road & Bean Road Intersection

Maureen Brescia, another concerned resident, recommended that a sign be placed on Mooar Hill Road at this intersection due to the fact that 3 vehicles in the past 2 weeks have ended up in newly graded ditch on the opposite corner. All 3 of these vehicles were turning left off of Mooar Hill Road and heading North on Bean Road. The corner was cleared 2 weeks ago to remove the blind corner and provide improved visibility to drivers, but it seems that with the new visibility, people are driving faster and more reckless than ever. There is concern that someone will be seriously injured if there is no deterrent.




COVID19 SURGE and BOOSTERS UPDATES, plus ARSENIC IN THE WATER

Lots going on; let's take these in reverse, most urgent, order

The surge of covid infections here in Maine continues to increase and now exceeds the first two (see graphs as of 11/18/21 below), undoubtedly due to the much more transmissible and virulent Delta variant, plus pockets of families and counties with lower vaccination rates than the rest.




People are often confused by the increasing numbers of "breakthroughs" in the fully vaccinated in cases and other outcomes, thinking those outcomes indicate vaccination failures. Rather, breakthrough numbers are increasing because vaccination rates (Maine at 73% or about 950,000 people) are increasing compared to the unvaccinated (25% or about 350,000). As the former goes up, the other goes down. If both groups were suffering similar case, hospitalization, ICU/Ventilator, and death rates, vaccinated people would be suffering 3 times as many of those outcomes as among the unvaccinated

people. Instead, those numbers are way more the reverse; bad outcomes in the unvaccinated population are roughly 10 times the numbers in the vaccinated. That's called a "base rate effect," which is seen nationally as well (see graph below). That degree of protection, though, as in all medical treatments, is not 100%, is all the more impressive given that the breakthrough cases are seen predominantly in people with pre-morbid conditions (diabetes, immune suppression, chronic lung disease, etc), rates for which tend to be much lower in the younger and unvaccinated now.

Rates for vaccinated and unvaccinated

Data from the Centers for Disease Control and Prevention shows that people who are unvaccinated are at a <u>much greater risk</u> than those who are fully vaccinated to test positive or die from Covid-19. These charts compare age-adjusted average daily case and death rates for vaccinated and unvaccinated people in the 14 states and two cities that provide this data. Boosters: last month I urged all who qualified, to get boosters if more than 6 months out from a Pfizer or Moderna 2-shot series, or 2 months out from the single Johnson and Johnson primary immunization. Governor Mills and her staff have recognized how hard people are finding it to figure out if they qualify or not and have changed the rules so all people, no matter their age, can get boosters. The federal CDC continues to recommend restricting boosters to just high-risk people, but will likely liberalize in a similar manner soon. However, chain pharmacies like CVS, Walmart, and Walgreens may not open to all until the federal CDC makes that change. So, get a booster now! They work to increase your immunity!

Finally, Arsenic: As many in Vienna know, the Kimball Pond Rd spring has been recognized to have Arsenic levels consistently above the national safety guidelines and may have to close or have the risk to users mitigated in some way. I am exploring those choices with the owners, the Vienna Historical Society. Meanwhile, I've discovered one other nearby home on Kimball Pd Rd, where the owners have identified a similar elevation in their drilled well and have wisely gone to bottled drinking water to protect their young children and the parents as well. I suggested the town test the fire station drilled well, and that water's arsenic level is ok.

I worry that there may be other clusters of water sources where only 1 or 2 households have identified the high levels. I'd ask anybody, in any of my 3 towns, who may have found high levels of arsenic in their water, to let me know, even if you have remediated the problem. I will urge neighbors around such wells/springs to have their water tested to be sure they are safe.
