Kurt and Susan Morse presented their subdivision site plan review application to the committee. Wright read the application aloud. There were some clarifications made by the Morse's in reference to the application submitted. All preliminary criteria was met and site plan was set for May 18<sup>th</sup> 2019 at 10:00am the Morse's will meet the planning board party at location of inquiry. After site plan review is complete Public Hearing is planned for this application May 21, 2019. The Morse's will notify the abutters within 300ft of the vicinity in question. Cauldwell said it would be best if they received a copy of the notification and signed it and bring a copy.

Fred Webber presented plans to the committee about deeding some land on the Dill rd. that was originally deeded to be given to the Town of Mt Vernon, where the Selectboard refused to receive the land at an unmentioned time some years ago. The land is instead to be given to the respecting abutters. The committee agreed to move forward. Cauldwell made the stipulation that a physical copy of letter be given to the abutters in the vicinity and a copy be given to the committee. More information will be gathered about this project.
