7:00pm Open Regular Selectmen's Meeting- Crockett called meeting to order.

7:01pm **Approved minutes**. Dyar motioned to approve minutes of the 10/02/17 meeting. Jackson seconded. Vote 3-0 in favor.

7:02pm **State tax valuation and abatement recommendations**. Dyar motioned to sign the municipal valuation return. Crocket seconded. Vote 3-0 in favor.

**Certificate of abatements**. There are multiple certificate of abatements for the Select Board to review. Dyar motioned to sign the certificates of abatements. Jackson seconded. Vote 3-0 in favor.

## 7:15 pm Other business.

-Beach update. Work began today. Dyar will be working closely with them throughout the project. The present driveway will be moved slightly to the left. There will be a meeting Wednesday night (October 18) regarding the work being done at the boat launch. The work at the boat launch should be done in the next week.

The grant from the state is a reimbursement grant. The Town needs to decide where they will temporarily access the money until they are reimbursed. Marti stated the amount will come out of the Grant fund. Dyar motioned to take the money from the grant fund account to cover this cost. Crockett seconded. Vote 3-0 in favor.

-There was a question about the work at the beach interfering with Halloween festivities. The work will not interfere with the Halloween festivities.

-Dyar met with the insurance company. The lights in the basement need to be fixed. At the community enter there were no problems Dyar went to the library with him and the insurance company will wait until next summer, but they would like to see the building plans. At the fire station there is an emergency light that is not working. Crocket will inform Dana Dunn that it is not working. On the rescue side of the building there were three bottle of oxygen that need to be relocated. There was a discussion about a leak in the roof at the Transfer Station.

-There was a question about a discount on excise tax for disabled vets. Rachel is going to a meeting and will look into a legality of this and give a recommendation to the Board.

-The Comprehensive Plan committee has been field testing their survey and will be sending it out to citizens. Crockett motioned to take up to \$250 out of the municipal budget for a Comprehensive Plan survey. Dyar seconded. Vote 3-0 in favor

There was question of a quick claim deed and the Board decided to table it pending payment of personal property.
