7:01pm **Approved minutes**. Jackson motioned to approve minutes of the 8/20/18 meeting. Crockett seconded. Vote 3-0 in favor.

7:02pm **Abatements**. Crockett motioned to approve abatement of \$589.95 for Ethan and Vanessa Buuck. Crockett will check with assessor about an abatement for the previous year. Jackson seconded. Vote 2-0 in favor.

7:10 **Community Center Contract**. Ben Lowder made new recommendation for community center steeple roof. The price will now be \$8,912.75. Crockett motioned to accept bid. Jackson seconded. Vote 2-0 in favor.

- 7:20- **Community Center painting**. Contract was signed with Tom's Painting for painting of community center trim. It was approved last year.
- 7:25- Maine General sent a **memorandum of agreement** to allow Dan Onion to oversee Mount Vernon Rescue. Crockett motioned to sign. Jackson seconded. Vote 2-0 in favor.
- 7:30 **RSU 38**. Alex Wright shared information about RSU 38 bond proposal for \$5,843,710. The project list shows nothing for Mount Vernon Elementary. There was discussion as to oversight fees and

potential conflicts of interest with the company that drew up the plans. There was further discussion regarding whether all projects would go out to bid.

A January referendum was proposed by the RSU but November would be better from both a logistical and financial perspective. Wright requested the Board write a letter to the RSU stating we prefer November. Crockett motioned that the Select Board will draft a letter to the RSU. Jackson seconded. Vote 2-0 in favor.
